BC theatre department to close out spring term with Thriving

Thriving is defined as prospering or flourishing. Professor Mariah Reed of South Campus' Theatre department and director of original production Thriving, defines it as success in the face of difficulty. "It's important to highlight the courage of an individual to get through something."

Thriving was previewed during the AHCD Pathway's Springfest on March 16, four days before the production would go into its rehearsal process. The event was hosted by Professor Reed alongside Professor Natalie Taveras. The official production had a three-day run at South Campus' PCAT theater from April 21-April 23.

During the preview, various cast members read selections from the nearly finished script which consists of fifteen scenes inspired by true life

stories. The scenes tackled an array of coming-of-age experiences. The material ranged from emotional to inspiring and covered topics regarding body image, societal pressure and the intersection of self-disclosure and sexuality.

Thriving sets out to validate human experiences and show there's hope for those facing adversity. The purpose of the stories Thriving tells will be for its viewers to realize they're not alone in what they struggle with. "It's inspiring to see people get the tools [they need]. People like this exist. They're not just surviving, they're thriving."

This topic may come off as an oxymoron to Thriving's target audience of college students. The pressures of finals, projects, applications and deadlines may be far from validating a student's personal struggle, but it highlights an important conversation to be had about the culture of college life

"We've lost the importance of self-care." Prof. Reed spoke of the prioritization of assignments and due dates over student's well-being. When talking about the background of the play, Prof. Reed explained 70 percent of the adult U.S. population experiences trauma at some point in their lives. "It's time for something that's just addressing the elephant in the room. Artists have a responsibility to heal humanity." With writing about young adult coming of age experiences comes the dilemma of how to approach sensitive material that can make audiences uncomfortable. Thriving will have trigger warnings and the Theater department has worked with the Wellness department to provide various resources to whoever may need it. "It is an uplifting piece, I promise!" Reed emphasized leading the previously quiet audience into

laughter.

The cast of nine members who took stage for the play's preview described a pleasant creative process and equal input into the making of the play with Prof. Reed. "Mariah creates a space where she values our input as much as hers." A cast member, who'd just acted out an emotionally jarring scene alongside her castmate centered around 'coming out', explained. The Broward

College Theatre department prides itself in producing original theater productions and allowing their students to be vastly hands on in the creative process of theater production. "We encourage all students to be a part on or off stage."

Students learn about screenwriting in Hollywood

The first annual SpringFest Festival brought many special guests. BC students had the opportunity to virtually meet Kamaran Pasha, screenwriter, producer, novelist and screenwriting professor at Penn State on March 15. The Zoom Meeting was hosted by James Eimmerrman, film professor at Broward College, producer and writer

It is not often that you have the opportunity to meet someone so honest about his highs and lows in Hollywood, how he got there and his tips for fellow writers.

Pasha's work includes being a writer and producer for the NBC series Kings and contributing with his writing to other shows such as Sleeper Cell, Tron: Uprising, Reign, Roswell: New Mexico and Nikita. He also wrote the video game 50 Cent: Blood on the Sand.

Storytelling had always been Pasha's passion. As a child Pasha would make his own films in his mind by playing with his action figures, intuitively making a beginning, middle and end to them. But, like many, he did not see screenwriting as a realistic profession.

"I think all artists are born, and probably know that they're artists as children, but most of us end up, as we are getting older, being told by our environment, our parents society, that it is just not a feasible career option. 'How are you gonna make money doing that?' It is a standard thing you are told when you are a creative person."

He majored in Religion at Dartmouth, worked a few years as a journalist, and after obtaining his JD and MBA, he worked as a lawyer in New York. He did not feel fulfilled or happy with his career, even though he was making good money, so he decided to try what he believed was the worst possible way of getting into Hollywood: sending unsolicited emails and letters to agents and people who worked in the industry without being known.

The reality is that the best way to break into Hollywood, and other industries, is by knowing someone big who is already in. But Pasha's way eventually gave in. He reached out to people sharing the teen

horror script he had written at school and waited for a response.

Most did not answer, and the few who did said they did not accept unsolicited submissions. Months later, his screenplay was seen by an agent that liked it and eventually got sold to Paramount, that was about 22 years ago.

He sold his second script to Paramount and was automatically inducted into The Writers Guild of America, the union for screenwriters. "I thought, wait a minute, I just became a professional screenwriter by accident and I'm still working my full-time job as a lawyer. And I did the scariest thing possi-

dent and I'm still working my full-time job as a lawyer. And I did the scariest thing possible: I quit my job as a lawyer and moved to Los Angeles." He shared he had beginner's luck, since the third script he

wrote took longer to sell. But

that eventually came through and he has been able to work professionally ever since.

Pasha recommends young writers to learn their craft and study life to become good story tellers. He has seen most young writers plan to join the film industry by taking an assistant job on a production. "Most young people I know on that track never get that door open. Hollywood takes advantage of assistants. Very rarely do their 'mentors' ever give them any feedback, much less training. The ones I have seen succeed are the ones that came later in life, that had a different successful career, any career that gave them life experiences."

These people can show up in their late twenties, thirties, even forties, and share stories. "It is always good to come out to LA, but learn your craft, which is learning about life, and read stories like the great classical stories of the human condition that have survived. Sure, if you want to be a screenwriter you should be watching movies, but even more, you should be expanding your mind through literature.





NBA's Innovative Technology Vs the NFL's

The relatively new technology is called STATS SportsVU, which is used for NBA games. It is a very in-depth player tracking device, that is being used to further the viewing intricacies of NBA basketball. This technology has already started to revolutionize how the NBA is viewed and watched around the world. Every year the main goal is to try and improve this multifaceted technology.

STATS SportsVU is basically a multifaceted system of 6 high resolution cameras, that is a top notch and state of the art computer vision technology. This particular technology immediate divulges and unorthodox statistics, which are solely based on player separation, distance, speed, and ball control. The main reason for all of this is so that they'll have a comprehensive data of all teams, players, and even referees now. It was first used in the NBA in 2009. Then in 2013, this technology was used for all teams in the NBA. NBA teams use all this tracking data for player development, training, and scouting new players.

STATS SportsVU uses the way players align themselves offensively and defensively, compared to where the basketball's trajectory might be located, passes made by players, and the number of dribbles taken. All players, referees,

and the basketball are tracked around 25 times a second. The next process is the particular software will analyze the videos, and then it stores all the info that was recorded. Also, it then adds around one million entries every game to its database.

STATS SportsVU allows teams to not have to track and chart a game by watching it and writing it down. This also allows for exact player positioning, and tracks how close a defender might be to a particular player. This technology definitely makes the in-depth defensive stats a 100 percent more quantifiable, especially to see who has the most defense impact and who might win defensive player of the year.

SportsVU Since STATS is already the official player tracking parter of the NBA, it is now currently being used my different sports networks like ESPN, NBA on TNT, Bleacher Report, NBA TV, etc. All the data that is contracted will be widely available to all other media outlets everywhere. This will definitely provide unforeseen insight for fans about players shooting, players, passing, players rebounding, players defense, substitutions, different play calls, lineups, etc. In the past, STATS SportsVU data was only made available for the NBA teams, now it is available to everyone and everywhere.

Jordan Rosen, who is a senior Vice President at STATS SportsVU said, "we look forward to taking our partnership with the NBA to the next level by making STATS SportsVU data available to media outlets

around the world." Also, he said, "by making available a robust set of innovative data, we can provide a more sophisticated level of analytics to NBA fans across a rapidly growing number of platforms." Steve Hellmuth, who is an NBA Executive Vice President of Operations and Technology said, "this expanded partnership with STATS will give fans new opportunities to access SportsVU's groundbreaking statistical information across numerous media outlets. allowing them to deepen their understanding of our game.".

In 2006, the NBA and STATS had originally partnered up to bring NBA teams and players stats that they can use to get exponentially better and win a championship. STATS SportsVU is now used by NBA TV, NBA.com, the NBA app, etc. STATS LLC and the NBA had partnered up to expanding their continually growing partnership. This partnership gives everyone complete access to everything pertaining to player tracking data.

The world's leading sports technology is STATS LLC. Their main goal was to revolutionize how sports were perceived, how they were view, enjoyed, and even played. STATS always provided historical sports information, fantasy sports operation, every score for all games, brand activation solutions, Associated Press editorial content, and SportsVU technology. STATS

Unlike the NBA with STATS SportsVU, the NFL's technology called radio-frequency identification transmitters (RFID). It was created by Zebra Technology, and since 2014, it has been put in players shoulder pads. This innovative system collects data on players speed, position, distance, etc. Theses transmitters have also been placed into footballs, to measure a variety of things. Then the data could be seen on NFL Microsoft Surface Tablets, so that they could use it to apply in-game adjustments.

STATS SportsVU readily available to every arena from 2013-2017 NBA season. In 2017, they added another technology to STATS SportsVU which was called Second Spectrum. In 2013, all 30 NBA teams have installed the STATS SportsVU camera, which was made possible from the partnership between STATS LLC and the NBA. In this year's NBA playoffs, STATS SportsVU has enhanced the way we watch playoff games. It provides different angles, views, perspectives, and backgrounds to watch the playoff game, in a more interactive way.

NBA Playoffs News and Notes

The NBA regular season ended Sunday April 9; and then the Play-in Tournament went from April 11-14. The majority of Playoff/Play-in teams facilitated trades to bolster their respective rosters, to solidify their playoff spots, also to rise up to or from the play-in tournament. The main differences between the Play-in Tournament and the Playoffs are extra needed rest, more games played, 1 game elimination games (depending on your seeding), etc.

The Suns acquired KD and T.J. Warren from the Nets for; Mikal Bridges, Cam Johnson, Jae Crowder; 2023, 2025, 2027, 2029 unprotected 1st round picks, and a 2028 pick

KD vs Kawhi

1st scoring option and has been extremely impactful in that role by averaging basically 26 points. Unsurprisingly that continued in the playoffs, in game one 121-101 loss to the 76ers, Bridges scored already his career high, 30 points. Then in a game two 96-84 loss to the 76ers, Johnson scored 22 1st half points, which was already his playoff career high, and finished the game with 28 points. I think eventually their traded players, will lead to pivotal wins in game three and/or four. KD's impact has be monumental, and he was also able to recover from his sprained ankle to play the last couple games of the season. The Suns were 8-0 in the games he played, until they lost game one to the Clippers 115-110, even though KD almost had

swap. Bridges has been their a 27-point triple double, and without an injured Paul George. Kawhi Leonard vs KD's duel ended with Kawhi having 38 points and the win. Early in trade deadline, the Lakers acquired Rui Hachimura for Kendrick Nunn, and three 2nd round picks. The Lakers, Timberwolves, and Toscanini-Anderson,

Jazz, executed a three-team trade that finally sent Russ, Juan Damon Jones, and a lightly protected 2027 1st round pick to the Jazz for D'Angelo Russell, Malik Beasley, and Jared Vanderbilt. the Timberwolves Also, received Mike Conley, Nickiel Alexander-Walker, and a 2024-2026 2nd round picks. Lebron returned from his injury and was able to return for the last couple games of the season. The Lakers were able to win their play-in

which was obviously their playoff career highs. The Clippers, Rockets, and Grizzlies executed a threeteam trade, that sent Eric Gordon to the Clippers; John Wall and Danny Green to the Rockets, Luke Kennard and three 2nd round picks to the Grizzlies. These trades have provided the Clippers with more depth and shooting, also

it has reinforced the Clippers as championship contenders. Gordon was extremely effective in their 115-110 win vs the Suns, with him having 19 points and three 3-pointers. The Clippers decided to sign Russell Westbrook for a true point guard attribute. Westbrook's impact was extremely evident because even though he shot 3-19 in the game one win, he was able to make key plays in the clutch like an offensive rebound which led to a 3-point assist to Kawhi Leonard, two clutch freethrows, also a block and forced turnover on Devin Booker.

The Knicks acquired Josh

Hart from the Blazers for Cam Reddish, Ryan Arcidiacono, Svi Mykhailiuk, and a 2023 lotteryprotected 1st round pick. Hart's impact on the Knicks has been exceptional because he has reinforced the Knicks culture, and also has solidified their playoff berth and especially expectations. In the Knicks game one 101-97 win vs the Cavaliers, Hart provided a 17 point double-double, and hit a clutch 3-pointer while staying in the game after spraining his ankle. He was able play in their 107-90 loss to the Cavaliers, even though he wasn't 100%. The immediate signing of Kevin Love, proved to be extremely pivotal for the Heats' game one 130-117 win vs the Bucks. He had 18 points, 8 rbs, four 3-pointers. and a couple of drawn charges, which essentially aided space for Jimmy Butler and Bam Adebayo, with Butler having 35 points, 11 assists, with 3 stls, and Bam almost having a 22 point double-double. Sadly, Tyler Herro broke multiple fingers on his right hand; he was dominant before that happened, and is officially ruled out until the NBA Finals. Also, Giannis Antetokounmpo aggravated his tailbone, and is basically doubtful to questionable for the rest of the series.





AI Voice Theft: Does AI have the power to change the music industry?

Every famous vocalist brings their own unique voice to the table. Ariana Grande has her sultry, weightless voice that effortlessly floats from note to note. Mariah Carey has her soulful wide-range agile voice that allows her to make vocal leaps that most find impossible. Rappers like Kanye West and Kendrick Lamar have distinctive cadences and that make their songs and features stand out. These unique voice characteristics, along with their musical talent, are what attracts people to their songs and maintains their place in the music industry. However, recent developments in AI technology can potentially make the years spent perfecting their craft obsolete with a couple of clicks.

Diff-SVC, developed by students of The Chinese University of Hong Kong, is a singing voice conversion model aimed to replicate a natural human singing voice while eliminating the unnatural

features and choppiness of its predecessor. The model can copy the original characteristics of any voice that it is given by being trained with short, 15-second voice samples. After enough voice samples are given, a voice model is made and then can be copied onto any reference audio. From here, any voice can be made to sing any song, whether that would be an English-speaking voice being made to sing a song in Mandarin or a Japanesespeaking voice made to sing a song in Russian.

With this technology, users have been able to make covers of songs using a wide variety of well-known celebrity voices, such as a cover of Reggaeton song "Envolver" by Anitta using Ariana Grande's voice to sing in natural sounding Spanish with her signature vocal flair or a cover of popular Vocaloid song "Lagtrain" by inabakumori with Peppa Pig's voice singing near fluent Japanese. But covers are not the only thing that have been made with this technology, as YouTuber Roberto Nickson has been able to make his own original rap song using a Kanye West voice model trained with SoftVC VITS, a similar technology to Diff-SVC, which has gone viral on both TikTok and YouTube platforms.

Without a doubt, these technologies have the power to have a colossal impact on the music industry, but it may not be a solely negative one. These days, it is hard to obtain a stable footing in the music industry, especially as an up-and-coming producer or a non-singer in general. We have seen musicians such as Kenshi Yonezu, known well for his songs Peace Sign and KICKBACK, and Eve, known for the Jujutsu Kaisen opening, Kaikai Kitan, break out into the music industry using similar voice synthesizer technology named Vocaloid, created almost two decades ago, and become massively By popular. weaving well known voices into their music, independent musicians can have their songs gain a wider reach and find community in fellow voice synthesizer

This technology is not completely innocent, though, as anyone's voice, celebrity or not, could be stolen and toyed around with, being made to sing offensive lyrics or read out long, racist tirades, which has the potential to ruin the reputation of the voice reference used. Diff-SVC already has rules stating that any use of the technology should be labeled as such, but there could be legal regulations in the future made to ensure that voices are used with certain rules and permissions in mind. Voice Synthesizer technology's rapid advancement is not slowing down for the law, but the wide use of this technology can push those laws to finally be made, letting musicians experiment with the technology ethically and

Stop W.O.K.E. Act: How suppression is one step closer to oppression

In recent years, race, political correctness, and being "woke" have been at the forefront of American political discourse. There has been a growing emphasis on educating oneself about social injustices, speaking out against inequality, promoting diversity and inclusivity, and being aware of personal biases related to race, gender, and sexuality. Supporters see these efforts as progress to true equality in the United States, while critics argue that the increasing focus on being woke can lead to the widening of the divide among Americans, censorship of non-liberal opinions, and even indoctrinate children with beliefs that shame them for their own race. In response to the worries of critics, Flori-Governor Ron DeSantis has embarked on a campaign to end the spread of woke ideology, with the teaching of Critical Race Theory being a main target for the ideologies it keeps alive. But what really is Critical Race Theory and how are its teachings harming America's youth?

Critical Race Theory (CRT), according to the First Amendment Encyclopedia, was first developed by law scholars in the 1980s to critically think about America's laws and legal

framework after they recognized that many of the ongoing changes made in the civil rights era had made a gradual stop or had been completely reversed. With their analysis, they have come to the conclusion that racism is built into the framework of America's society, and that the law can either be used to uphold racism or protect civil rights. As long as society continues to benefit from the survival of racial inequality, it will persist in living, and things such as diversity initiatives only prove to recognize an effect of inequality without addressing it as its source. In short, CRT is a cross-disciplinary examination between law and racism used to understand how racism is kept alive, how it affects racial minorities in ways that cannot be avoided, and what we can do to terminate it from the roots.

CRT has evolved to be taught in courses in law-focused universities and colleges as another form of dissecting and learning law. It challenges course takers on what they currently know about law, justice, and race and to think about ways that oppression is embedded into America's society. K-12 children are not offered ways to learn the rigorous course at their grade levels, but some deem history teaching principles like systemic racism and racial privilege to be adjacent to CRT tenets.

The Stop the Wrongs to our

Kids and Employees Act, commonly abbreviated as the Stop W.O.K.E. Act, aims to disallow K-12 professors and teachers from teaching apparent CRT tenets to students.

This is codified by banning instruction that teaches that one race is inherently superior to another, that leads students into feeling any sort of psychological stress due to their race, that teaches students that an individual is racist due to their race alone, that hard work is racist and not fundamental to the pursuit of happiness, etc. It also protects employees from going through character development training that influences them to feel guilt about their race or think badly of themselves due to their supposed racial privilege among other similar CRT "adjacent" teachings. Though the legislation of these rules can be seen as a step in the right direction, their misunderstanding of the concept of CRT and vague language can lead to serious consequences regarding the accurate retelling of history ahead.

The purpose of CRT is to open conversation about how inequality and racism continues impacting our communities. It exists so we can learn to identify where changes must be made in our society in order to move forward together and not backtrack. And it should not disappear because it conflicts with a presidential cam-

paign strategy that includes the "Parental Rights in Education" bill, referred to as the "Don't Say Gay" bill, that prohibits K-12 students from learning about sexual orientation, gender identity, and CRT.

When DeSantis announced his proposal for the Stop W.O.K.E Act, he stated that his administration "won't allow Florida tax dollars to be spent teaching kids to hate our country or to hate each other." Those who continue with what he called a so-called "indoctrination of children" will suffer consequences, which include limiting state-funds, civil liability, and firing personnel, for not abiding with the legislation.

This has created a fearful atmosphere, where professors without tenure would rather leave than teach their CRT related courses. So was the case of Jonathan Cox, University of Central Florida assistant sociology professor, who spoke to ProPublica about how he decided to not teach his Fall 2022 classes that covered colorblind racism and the impact of race-neutral practices. He did not have the possibility of being considered for tenure that fall. "I'm completely unprotected. Somebody who's not even in the class could come after me. Somebody sees the course catalog, complains to a legislator - next thing I know, I'm out of a job."

This anti-CRT act has also led public school libraries to remove thousands of books and put more than a million in review in fear that they show inappropriate imagery.

Because of DeSantis's unclear explanation and misinterpretation of CRT, which, in truth focuses on analyzing how our country's racist past still impacts us today and not on motivating divide, how can school faculties not be scared?

Teachers and students who filed a lawsuit against the Stop W.O.K.E act in March last year emphasized that "these laws are unconstitutional viewpoint-based restrictions on speech that regulate the speech of Florida teachers and business owners in violation of their First

with vague definitions in order to chill protected speech."
If students are not taught about inequality in the classroom, they will not know what to do about it when they encounter real acts of oppression in their community. Not teaching the full scope of inequality is as if we are suppressing our past.

And suppression is one step

closer to oppression.
